3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Junior sewer system worker/road worker are:

- assists in installing traffic control measures and their maintenance;
- prepares the work site; secures cables and pipelines to prevent damage;
- assists in earth moving;
- assists in building the road foundations;
- assists in construction of sewer system and keeping trenches open;
- assists in the construction of verges;
- assists in installing drains, kerbstones, discharges, manhole edges and manholes;
- helps to repair settlement and damage to road surfaces and elements;
- assists in application of a temporary road surface;
- assists in the installation of street furniture, fences and screens;
- leaves the work site in the agreed condition.

For his work, he often works with colleagues, drivers and operators of earth-moving machinery.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
