3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Moped mechanic are:

- 1.1 Prepares maintenance work on two-wheelers
- 1.2 Performs inspection of two-wheelers
- 1.3 Performs service on two-wheelers
- 1.4 Makes two-wheelers ready for delivery
- 1.5 Checks the maintenance work and rounds off the job
- 1.6 Gives (technical) explanation to the customer about the performed service

Core duty 2: Makes repairs to two-wheelers

- 2.1 Prepares repair work
- 2.2 Makes a diagnosis on two-wheelers
- 2.3 Repairs two-wheelers
- 2.4 Checks the repair work and rounds off the job
- 2.5 Gives (technical) explanation to the customer about the performed service

Core duty 3: Sells parts and accessories

- 3.1 Receives and approaches customers
- 3.2 Holding sales talks with customers
- 3.3 Carrying out cash sales and completing sale

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Moped mechanic works in a moped (and bicycle) store.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>2 years (3200 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
