The most important duties of an IT media production are:

In the training for the gualification IT media production you can choose for two options: the more technical way, IT management or the commercial way. IT commerce. The IT manager actualizes, maintains and manages the information system for media productions and the network where this system belongs to. He is responsible for the quality, contents and utility of the information system. When you choose for the option IT commerce, you will be the link between the IT manager, the operators, other experts and customers. It is your responsibility that media production process works out well. You consult the operators and the customers.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

He can work at communication companies, advertising agencies, specialized design agencies and styling studios, webdesign agencies, multimedia companies, audiovisual companies, television production companies, printing offices and publishers. These companies and agencies often use their own names for positions in this sector.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
