3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled host/hostess are:

The tasks of the Skilled host/hostess can be qualified partly as executive and partly as controlling. It concerns preparatory activities, looking after and advising quests, processing data in the accounting system and closing activities. The Skilled host/hostess will carry out this work especially in luxury restaurants. The behaviour of guests in such establishments is more difficult to predict than in other establishments.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Skilled host/hostess in (luxury) restaurants and hotels.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
