#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Aircraft maintenance mechanic are:

The Aircraft maintenance mechanic installs mechanical and electrical parts. He works on a variety of aircraft systems such as communication systems, navigation systems and flight guidance systems. He also maintains the undercarriage, surfaces and body of the aircraft. He makes use of a variety of basic skills such as metalworking, sheet metalworking, mechanical measurement and the production of working drawings.

The Aircraft maintenance mechanic must be able to work with work charts. Safety is always the top priority in carrying out this work.

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Aircraft maintenance mechanic with an airline or at an airport.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
