3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled motorcycle mechanic are:

Core task 1: Performs maintenance of motorcycles

- 1.1 Prepares maintenance work on motorcycles
- 1.2 Performs inspection of motorcycles
- 1.3 Performs service on motorcycles
- 1.4 Fits accessories to motorcycle
- 1.5 Supports and instructs apprentices and colleagues regarding maintenance work
- 1.6 Checks the maintenance work and rounds off the job
- 1.7 Gives (technical) explanation to the customer about the performed service

Core task 2: Makes repairs to motorcycles

- 2.1 Prepares repair work on motorcycles
- 2.2 Repairs two-wheelers
- 2.3 Supports and instructs apprentices and colleagues regarding repair work
- 2.4 Checks the repair work and rounds off the job
- 2.5 Gives (technical) explanation to the customer about the performed repair

Core task 3: Makes a diagnosis on motorcycles

- 3.1 Prepares diagnosing motorcycles
- 3.2 Makes a diagnosis on motorcycles
- 3.3 Checks the diagnosing work and rounds off the job
- 3.4 Makes sure knowledge is shared in the company
- 3.5 Gives technical explanation to the customer about the diagnosis

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled motorcycle mechanic works in workshops of motorcycle companies from the mobility sector and carries out inspection, maintenance, and repair works on motorcycles. The mobility sector consists of companies that sell, rent, maintain, and repair passenger and company cars, caravans, trailers, scooters, bicycles, motor cycles, and mopeds. This is including towing and salvage companies, petrol stations, and carwashes.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
