The Agogic worker mental healthcare works on an ambulant and/or intramural and/or semi-mural basis within residential, daycare and leisure institutions within mental healthcare among others. Aside from that she works within welfare institutions, judicial institutions, asylum centres and hospitals. She can also work in other agogic

The Agogic worker mental healthcare offers support to clients of any age with psychic or psychiatric syndromes and/or disorders or an addiction, often with multiple problems within various areas of life. The clients have one or more mental health problems which influence their ability to function physically socially and societally.

The Agogic worker mental healthcare can develop through higher professional education, such as the education Social pedagogical aid or Nurse (higher general education). | International agreements The profession of Agogic worker mental health care is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive. |

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
