3. PROFILE OF SKILLS AND COMPETENCES

- The most important duties of a Social pedagogical carer 4 residential supervision are:
- that he/she maintains a direct relationship with the day-to-day affairs in the living environment;

- that he/she focuses activities on both the individual and the group.

The Social pedagogical carer 4 - residential supervision operates in a primary - whether or not replacement - living environment. In the case of a replacement living environment, he/she will be dealing with individuals placed generally on the basis of a social, judicial or medical indication. As a result, they require additional supervision, support and assistance.

The Social pedagogical carer 4 - residential supervision will provide educational supervision to the individual and the group in residential and living situations, whereby the self-reliance of the individual will be encouraged as far as possible. He/she draws up, implements and evaluates a supervision plan (personal plan). He/she will carry out the tasks on the basis of specific methods. The Social pedagogical carer 4 - residential supervision organises individual and group-oriented activities.

The professional character of the care and service provided by the Social pedagogical carer is expressed in the planned, targeted and method-based structure of that care. The Social pedagogical carer is able to rapidly gain an insight into the demands or needs of the client, and is able to efficiently and flexibly provide the required care. The Social pedagogical carer plans activities and interventions, and interprets and records the effects there of. The Social pedagogical carer draws up a problem background on which interventions will be chosen. The Social pedagogical carer is responsible for the organisation of the care and service provision. If necessary, the Social pedagogical carer will consult with her own or other disciplines.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Social pedagogical carer carries out activities in a wide range of settings, in community, semi-residential and residential work forms. The group leader/group worker/social pedagogical carer works in:

- care for the disabled in for example residential homes, day nurseries, social housing;
- institutions for care recipients with psychological problems;
- remand prisons and other penitentiary institutions;
- day centres;
- Institutions for the elderly;
- rehabilitation centres.

International agreements The profession of Social pedagogical worker 4 - residential supervision is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
