3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Hospitality entrepreneur/manager are:

The emphasis of the work of a Hospitality entrepreneur/manager is on supervising managerial tasks. The Manager also records and monitors the (financial) situation of the business. The Hospitality entrepreneur/manager is responsible for the commercial, financial, operational and human resources policy of the establishment, with maximum profitability and continuity as the ultimate goals. He/She takes care of the business plan, the business operation and the business management. In addition, he/she assumes a hierarchical responsibility for personnel, sales, operational aspects in production and distribution, reception and accounting, food & beverage, financial administration, products, policy and business administration.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Hotel and catering entrepreneur/manager is employed in medium-sized or large hotels and restaurants.

5. OFFICIAL BASIS OF THE CERTIFICATE

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
