The most important duties of a Natural environment worker are:

- 1.1 Prepares the grounds for lay-out work
- 1.2 Carries out earth-moving
- 1.3 Installs sewer systems/drainage
- 1.4 Lays out water (ponds)
- 1.5 Lays out surfacing
- 1.6 Places constructional elements
- 1.7 Lays out technical provisions
- 1.8 Lays out parks and gardens
- 1.9 Rounds off the lay-out work

Core task 2: Keeps nature and living environment

- 2.1 Controls weeds, diseases and plagues
- 2.2 Carries out soil improvement
- 2.3 Maintains sewer systems/drainage
- 2.4 Maintains water(ponds)
- 2.5 Maintains surfacing
- 2.6 Maintains constructional elements
- 2.7 Maintains technical provision
- 2.8 Keeps parks and gardens
- 2.9 Leaves work environment well-kept

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
