3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Beautician are:

Core task 1: Carrying out beauty treatments

- 1.1 Makes appointments and prepares treatments
- 1.2 Carries out facial treatments
- 1.3 Carries out hand, nail and foot treatments
- 1.4 Carries out body treatments
- 1.5 Advises clients and sells products and services
- 1.6 Evaluates and completes the treatment

Core task 2: Preparing for independent business ownership

- 2.1 Analyses the market
- 2.2 Designs the business
- 2.3 Profiles and promotes the business
- 2.4 Purchases and manages stocks
- 2.5 Regulates the financial elements of (the start-up of) the business
- 2.6 Evaluates the business

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Beauticians can work in the following environments: a beauty parlour, beauty farm, sauna, chemists or perfumery. In addition, they can do promotion work, work as a representative for large brands or run a business. Most Beauticians are self-employed in a parlour at home with no staff.

Access to next level of education/professions The Beautician can rise to the position of all-round beautician. Working as a training instructor is also a possibility. Furthermore, promotion is possible as a business manager, a management position, or self-employed entrepreneur. Horizontal or vertical transfer within the beauty industry is possible to the qualification Hairdresser.	International agreements The profession of Beautician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95746 The education and training for this qualification is offered as of August 1, 2012.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
