3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Graphic intermediary are:

The Graphic intermediary focuses on the coordination of the production planning as well as on the monitoring of orders throughout the production process. The Graphic intermediary is responsible for a smooth adjustment of the creation- and production phase, that's why he/she is aesthetically and technically trained. Knowledge of the different output models of the communication branch is important, not from a producing point of view, but from the analyses of products and techniques. Knowledge of the (im)possibilities of these production processes, and the ability to give a quality opinion of the products in different production phases, are important. The Graphic intermediary is expected to show a great deal of autonomy as well as management, technical, organizational and financial skills, combined with administrative and social skills. Also essential is a resistant to stress and being accurate. The Graphic intermediary must be able to frequently shift attention due to the different aspects of the job and the many interruptions.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
