3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Nurse (general care) are:

Core task 1: Offering care and guidance in the nursing process

- 1.1 Takes a case history and makes a nursing diagnosis
- 1.2 Recognises imminent or existing health problems
- 1.3 Draws up nursing plan
- 1.4 Offers personal care and monitors well-being
- 1.5 Performs nursing activities
- 1.6 Supports a care recipient
- 1.7 Gives information, advice and instruction
- 1.8 Responds to unforeseen crisis situations
- 1.9 Coordinates the care of individual care recipients

Core task 2: Works on quality and professionalism

- 2.1 Works on one's own expertise
- 2.2 Works with other professions in the healthcare sector
- 2.3 Works on the advancement and assurance of quality
- 2.4 Coaches new colleagues, apprentices and/or volunteers

Aside from the aforementioned core tasks the Nurse (general care) carries out at least one of the following core tasks. Which core task(s) is/are applicable is mentioned on the diploma.

Core task 3: Provides nursing care and guidance in the hospital

- 3.1 Provides care and support during examination and treatment
- 3.2 Communicates with a care recipient in support of the treatment and rehabilitation

Core task 4: Offers nursing care and guidance in care, nursing and home care

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Nurse (general care) is trained to be able to work in all branches of nursing and care: hospitals, nursing and care homes, homecare, mental healthcare and disability care. The magnitude (four contexts) is required to be guaranteed to satisfy the Dutch BIG-law (Individual Health Care Professions Law). The target group the Nurse (general care) takes care of is very diverse. Among others the target group consists of: elderly care recipients with limited self care, among which psychogeriatric and somatic care recipients; the chronically ill; recovering care recipients; disabled care recipients; clinical care recipients; care recipients with psychiatric diseases and/or disorders; people giving birth, maternity nurses and newborns; children and youth with potential or existing risk to health or life.

<p>Access to next level of education/professions The Nurse (general care) can develop in other directions at VET-level, such as Social-cultural worker, or specialised further education, such as diabetes nurse or oncology nurse. She can also become qualified to become a supervisor in a nursing or care department. 5. OFFICIAL BASIS OF THE CERTIFICATE

The education and training for this qualification is offered as of August 1, 2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
