## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Warehouse worker are:

The tasks, responsibilities and authorities of the Warehouse worker are operational in nature. The activities take place in the warehouse and contribute to the optimum goods flow management. The profession occurs in small, medium-sized and large enterprises. The Warehouse worker reports hierarchically and professionally to the director/entrepreneur (small enterprises), the warehouse head (medium-sized enterprises) or warehouse group leader (large enterprises). The Warehouse worker above all bears responsibility for his own tasks. Work is above all routine

Task areas of a Warehouse worker are:

Reception and storage, order production and dispatch, advice on optimisation of reception, storage, order production and dispatch activities, proposals for warehouse layout, stock control, maintenance and cleaning work, advice on optimisation of working methods, activities relating to stagnations in order and goods flow, participation in consultation situations, loss, prevention-action points

Warehouse worker/logistic worker, reception worker, storage worker

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
