Core task 2: Prepares media production

- 2.1 Formulates a plan of approach (project plan)
- 2.2 Plans the media production
- 2.3 Organises the necessary services and materials
- 2.4 Organises the processing of materials

Core task 3: Coordinates media production

- 3.1 Manages the available time, means and flow of information
- 3.2 Manages delivery of media products

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Media manager generally works at companies such as communication firms, commercial agencies, (specialised) design studios, web design bureaus, multimedia companies, event organisations, audio-visual companies, TV-production companies, publishers and printing presses.

He can also work at companies with a separate department aimed at design, realisation and/or marketing media manifestations.

<p><b>Access to next level of education/professions</b> A Media manager can end up in various middle management professions of media companies. The following names are generally used for functions as which a Media manager can work: process planner, production supervisor, traffic manager or project coordinator. There are various higher professional management education which are suitable as a means of development in Media management, such as the Media &amp; entertainment management education. It is also possible to develop to a higher professional level through work experience.</p>	<p><b>International agreements</b> The profession of Media manager is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25199 The education and training for this qualification is offered as of August 1, 2015.</p>																					

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
