The most important duties of a Sales manager mobility sector are:

Core task 1: Manages the sales team

- 1.2 Is responsible for providing information to sales advisors
- 1.3 Carries out performance and assessment interviews
- 1.4 Makes or assesses suggestions for investments, training or improvements
- 1.5 Recruits, selects and sacks sales advisors

Core task 2: Determines and carries out commercial policy

- 2.1 Supports the management in the determination and performance of the commercial policy
- 2.2 Formulates and carries out sales plan
- 2.3 Manages the stocks of new and used cars
- 2.4 Is responsible for the financial administration and registration
- 2.5 Monitors and evaluates sales figures
- 2.6 Identifies and deals with complaints
- 2.7 Carries out acquisition
- 2.8 Maintains external contacts

Core task 3: Sells passenger cars and/or small commercial vehicles

- 3.1 Ascertains the client's needs and presents a suitable assortment
- 3.2 Looks into financing, leasing and insurance contracts
- 3.3 Determines the exchange value of vehicles
- 3.4 Carries out sales negotiations
- 3.5 Completes the sale

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Sales manager mobility sector works in the mobility sector. He is gualified to work as an independent sales assistant in the showroom of a motor vehicle business. This can be an official service dealer, a universal car, motorcycle, and/or light company car company or another entrepreneur.

International agreements The profession of Sales manager mobility sector is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90850 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
