- 2.3 Takes care of the space and household duties
- 2.4 Offers the child/the youth developmental activities

Core task 3: Carries out organisational and professionally related tasks

- 3.1 Participates in staff training and works on professionalization of the profession
- 3.2 Works on the improvement and assurance of quality care
- 3.3 Consults about the work with the stakeholders
- 3.4 Performs coordinating duties
- 3.5 Maintains a network
- 3.6 Performs policy-related duties
- 3.7 Performs management duties
- 3.8 Evaluates the work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Pedagogical child carer 4 works in a day-care centre, after-school child care, in an elementary school or a playgroup. This can be an independent organization for playgroup work or playgroup that is a division of a welfare organization, child-care organization or educational institution.

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

This certificate gives access to higher professional education (hbo), for example the programme Social pedagogical assistance, Pedagogy, Cultural social education, Teacher's training college or Social work and services. Through refresher courses and continuing education the Pedagogical child carer 4 can move up to specialist functions, for example in the field of training.

International agreements

The profession of Pedagogical child carer 4 is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
