#### PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Road transport planner are:

Core task 1: Plans road transport

- 1.1 Assesses transport assignments and applications
- 1.2 Acts as advisor and salesperson in making long-term contracts
- 1.3 Takes care of supplementary/ consecutive consignments for the transport
- 1.4 Formulates a transport plan
- 1.5 Guides assistant planners and drivers
- 1.6 Takes care of documents involved in transport

Core task 2: Supports road transport and completes the transport administration

- 2.1 Guides transport remotely
- 2.2 Deals with problems arising in the transport
- 2.3 Adjusts the transport plan to the circumstances
- 2.4 Completes the transport assignment administration
- 2.5 Inspects and analyses the implementation of the transport assignment

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Road transport planner works at a planning department of a road transport business, at a transport department of a transporter or shipper. From a distance, he plans and supervises the road transport and processes it administratively.

Access to next level of education/professions Within a company, the Road transport planner can rise to the position of main planner or transport manager. The planner road transport can do an advanced training for Manager storage and transport (level 4) or Warehouse manager (level 4).	International agreements The profession of Road transport planner is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
