3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic service and maintenance mechanical installations are:

Core task 1: Inspects equipment, installations, and systems

- 1.1. Prepares inspection of equipment, installations and systems
- 1.2. Takes precautions for inspection working duties

1.3. Performs sensory inspection of equipment, installations and systems

- 1.4. Performs measurements and tests on equipment, installations and systems
- 1.5. Makes an initial diagnosis and report results
- 1.6. Rounds off inspection work on equipment, installations and systems

Core task 2: Optimises equipment, installations and systems, and takes care of technical problems.

2.1 Rounds off inspection work on equipment, installations and systems

- 2.2 Take precautionary measures for troubleshooting and optimisation of equipment, installations and systems
- 2.3 Disassembles, modifies, repairs and assembles components of equipment, installations and systems
- 2.4 Checks and tests work performed on equipment, installations and systems
- 2.5 Delivers equipment, installations and systems
- 2.6 Rounds off maintenance and modification work

Core task 3: Locates technical problems in mechanical equipment and installations.

3.1 Does preparatory work for locating malfunctions in mechanical installations

3.2 Locates and analyses (complicated) malfunctions in the mechanical installations

3.3 Adjusts the mechanical installations and fine tunes them

3.4 Supervises less experienced colleagues

The Skilled mechanic service and maintenance mechanical installations works for service companies focusing on service, repairs, and maintenance on installations for warm tap water, and climate control (such as water pumps,

The Skilled mechanic service and maintenance mechanical installations carries out maintenance on mechanical installations and solves malfunctions which may be complex and performs possible repairs and modifications.

Access to next level of education/professions The Skilled mechanic service and maintenance mechanical installations can be transferred to technician service and maintenance mechanical installations - he might be working on complex installations -, maintenance technician measure and control technology, technician gas and infra technology or to a project coordinator. He can expand his knowledge to a skilled mechanic service and maintenance electro technology and instrumentation, skilled technician service and maintenance tool making or professions in the refrigeration technology.	International agreements The profession of Skilled mechanic service and maintenance mechanical installations is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
