3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor automation electronics are:

The Supervisor automation electronics is involved with electronic equipment in relation to automation. His primary tasks in this respect involve the testing, fault-tracing, maintenance and repair of electronic appliances/systems. The systems involved include mixing desks, synthesisers, samplers and for example medical equipment and transmission and reception equipment for data communication.

He is responsible for the implementation of his own set of tasks. In addition, he bears hierarchical responsibility. He supervises and monitors the application of automated routines and standard procedures, by others. He also combines and elaborates new procedures. In addition, he is in charge of service engineers, and is responsible for planning and coordinating activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor automation electronics works as a technical employee in service provision/instrumentation technology.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Supervisor automation electronics is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
