3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Well-being assistant are:

The Well-being assistant mainly carries out supervisory and care tasks. A proportion of the work also consists of domestic tasks. The precise nature of the package of tasks may differ considerably between individual care helpers. The differences primarily arise from the differences between client groups, the way in which the care, support and service provision is organised and the type of care support and service provision. In all cases, the objective is to support and contribute to the provision of care, support and services to the client.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Well-being assistant is able to work in positions in various fields of care, including care and nursing homes, home care, care for the disabled, care for the mentally disabled and care in a hospital setting.

5. OFFICIAL BASIS OF THE CERTIFICATE

Legal basis

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 2 year(s) (3200 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
