## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled recreation worker are:

The independent implementation, coordination and organisation of activities relating to the front office of a recreation company. The tasks of the Skilled recreation worker include:

- supervising guests (reception, accommodation and recreational activities);
- administration (for example bookings and reservations);
- sale and rental (for example bicycle hire).

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled recreation worker is employed in the recreational accommodation sector (campsites, bungalow parks, group accommodation and mixed businesses) or the day recreation sector (indoor and outdoor centres/ sports businesses, attraction parks and playgrounds). Within large companies, the Skilled recreation worker is often employed within the sport and recreation department.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
