- 2.4 Supports the client with financial problems and budget control
- 2.5 Mediates and supports the client with the protection of his interests
- 2.6 Performs information, advice and education work on behalf of the client
- 2.7 Performs information, advice and education work on behalf of groups

Core task 3: Perform organization- and profession-related duties

- 3.1 Participates in staff training and works on professionalization of the profession
- 3.2 Works on the promotion and assurance of quality care
- 3.3 Consults about the work
- 3.4 Evaluates the offered support

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Social workers work in many small and large organizations in the care and welfare sector. They work in various sectors (for example, health care, social relief and assistance) and they can be hired in various functions (for example, employee social assistance, and budget counsellor).

Possible jobs after the programme Social worker can be: social assistant, (social) counsellor, counsellor resident's affairs, relief worker, functions in the field of information and advice (such as telephone assistant), information functions, complaints officer, trajectory coach, advisor to the elderly or budget counsellor.

<p>Access to next level of education/professions This certificate gives access to higher vocational education (hbo), for example the programmes Social work and assistance, Social pedagogical assistance, Pedagogy or Cultural social education.</p>	<p>International agreements The profession of Social worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92670 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
