Core task 2: Carries out technical sewing actions

- 2.1 Prepares the working duties
- 2.2 Stitches the model
- 2.3 Carries out final inspection of model
- 2.4 Manages the profession technical standards

Core task 3: Manages the colleagues

- 3.1 Makes and monitors the planning
- 3.2 Instructs colleagues
- 3.3 Keeps supervision over the working duties
- 3.4 Monitors the staffing levels
- 3.5 Monitors the working atmosphere
- 3.6 Makes contributions to staff consultations

Core task 4: Develops the business product

- 4.1 Monitors the product quality
- 4.2 Carries out research into fashion developments

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Those having obtained the diploma of Specialist fashion/custom made clothes are qualified to work in a workshop of a company for mass-production, custom-made clothes and clothing repair/alteration. A reconditioning company is also an option.

<p>Access to next level of education/professions The Specialist fashion/custom made clothes can develop into specialist in due course.</p>	<p>International agreements The profession of Specialist fashion/custom made clothes is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91260 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
