Core task 2: Implements (parts of) information or media systems

- 2.1 Contributes to the implementation plan
- 2.2 Implements (part of) the information or media system
- 2.3 Gives support with the acceptance test
- 2.4 Evaluates an implementation

Core task 3: Manages (parts of) information or media systems

- 3.1 Prevents malfunctions
- 3.2 Localises and remedies malfunctions
- 3.3 Formulates and monitors procedures
- 3.4 Secures the information or media system

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Network manager works in the ICT and media sector. He usually works at ICT service companies, media enterprises or the ICT/media department of miscellaneous companies. It is also not unusual that a Network manager is seconded from ICT service companies.

<p><b>Access to next level of education/professions</b> Based on work experience, the Network manager can be promoted to a managerial position and after additional training to a position at the higher vocational education level. Within the higher vocational education, he can enter the programmes for Business information science, Information science, Technical information science, and Information services and management.</p>	<p><b>International agreements</b> The profession of Network manager is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95323 The education and training for this qualification is offered as of August 1, 2011.</p>																					

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
