3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Assistant installation mechanic heating technology are:

- Laying pipes for gas, water, sewer systems and central heating;
- Installing and final adjustment of wash basins, toilets, kitchen and bathroom appliances;
- Connecting geysers, boilers, central heating boilers and radiators;
- Carrying out maintenance and repair work;
- Inspecting and testing installations.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Assistant installation mechanic heating technology is employed in an installation company that provides sanitary and gas installations, and constructs and maintains existing installations. The work is carried out subject to the instructions of an installation engineer.

The skills of the Assistant installation mechanic heating technology are job-specific; however, there is a degree of overlap with the Assistant installation mechanic roofing and the Assistant heating mechanic.

With a diploma at qualification level 2, transfer is possible to a course at qualification level 3.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
