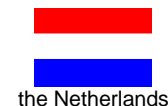

Certificate Senior Secondary Vocational Education Qualification: Baker and pastry cook This translation has no legal status

3. PROFILE OF SKILLS AND COMPETENCES
<p>The Baker and pastry cook has general knowledge of baking (working with perishable products, personal hygiene and personal care and clothing and of the various types of dough (yeast dough, crusty pastry and butter pastry), decorative work and hygiene.</p> <p>The work focuses on the following products:</p> <ul style="list-style-type: none"> - Yeast dough: unfilled large and small bread products; - Mixture, cakes and tarts; - Crusty pastry and short pastry.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
Baker and pastry cook in an artisan bakery. Generally a mixed company where bread and pastry products are produced and sold.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	2,5 years (4000 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
