### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Social pedagogical carer 3 - primary education are:

The Social pedagogical carer in primary education above all undertakes work in the lower years of primary education. He undertakes simple, education-based tasks, supports children in playing and learning, offers assistance in the field of safety and hygiene, offers social pedagogic care to pupils, contributes to a good pedagogic climate, delivers a practical and organisational contribution to class management, participates in consultation situations and supports in the organisation of school activities. The work is primarily focused on supporting the group teacher in working with children in the lower years. A Social pedagogical carer in primary education must be able to work in a range of situations, possibly at different schools. In particular in special education, care tasks relating to hygiene, personal care, social pedagogic care and class management will form part of the range of tasks of the social care worker in primary education.

A Social pedagogical carer 3 - primary education is active in the provision of care and services in the primary education. The professional character of the care and service is expressed in the planned, targeted and method-based structure, and the practitioner in this profession is responsible for the group of children between the ages of 4 and 12. He is capable of bearing responsibility, under supervision of and in accordance with a teacher, for drawing up an individual (care) plan, and also bears responsibility for the provision of care and services.

The Social pedagogical carer 3 - primary education undertakes work subject to the responsibility of a group teacher. Professional attitude aspects of the social care worker are demonstrated:

- interpersonal skills in respect of children, parents and colleagues;
- awareness of professional approach;
- awareness of own values and standards and those of others.

Social pedagogical carer in primary education, possibly in special education.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
