3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sports and exercise leader are:

- planning and implementing sport and exercise activities by determining the starting situation, developing a sport and exercise programme and implementing sport and exercise activities;
- bearing responsibility for the organisation;
- consulting and discussing with others within and outside the organisation.

The Sports and exercise leader is involved in the independent provision of sports and exercise activities. He/she commands technical sporting knowledge and skills, and is able to develop sports and exercise activities geared to a specific target group. The professional character of the provision of sports and exercise activities and the supervision of the sport and exercise participants is expressed in the planned, targeted and method-based structure.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
