## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Last maker are:

Core task 1: Makes lasts

- 1.1 Carries out preparatory work for making lasts
- 1.2 Models and makes lasts

Core task 2: Makes orthopaedic provisions for feet and shoes

- 2.1 Carries out preparatory work for the manufacture of orthopaedic provisions for feet and shoes
- 2.2 Makes inlays or supplements
- 2.3 Makes rehabilitation, bandage or orthopaedic fitted footwear
- 2.4 Manufactures shoe lining or inner skid
- 2.5 Manufacture orthopaedic shoe technical provisions on ready made shoes (OVAC), (semi-) ready-made orthopaedic shoes or personal pair.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Last makers work in orthopaedic footwear companies. These also include, next to specialist orthopaedic technical companies, companies which also design, adjust, manufacture and deliver orthopaedic instruments (orthosis and prostheses), besides orthopaedic shoes.

<b>Access to next level of education/professions</b> The Last maker can within the company continue to develop horizontally. He can specialise in his work by following courses. After obtaining his diploma Last maker he can also follow the course Orthopaedic footwear technician level 4 and continue to develop to develop into Orthopaedic footwear technician.	<b>International agreements</b> The profession of Last maker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95694 The education and training for this qualification is offered as of August 1, 2012.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
<b>Average duration of the education/ training leading to the certificate</b>	<b>3 years (4800 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
