3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor technician - industrial automated installations and systems are:

- Supervising and managing the work process;
- Supervising employees;
- Producing and reading drawings;
- Undertaking and checking cost calculations;
- Designing industrial automated systems and installations;
- Installing, commissioning and handing over industrial automated systems and installations;
- Modifying and maintaining industrial automated installations and systems.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The newly qualified Supervisor technician - industrial automated installations and systems works in companies from various sectors and of varying sizes. The Supervisor technician for example can be found in the sectors industry, services and maintenance and service companies. The size of the companies where the Supervisor technician is employed range from small and medium-sized enterprises to large businesses. The career prospects for a Supervisor technician lead to operational managerial positions or private entrepreneurship.

International agreements The profession of Supervisor technician - industrial automated installations and systems is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91145 The education and training for this qualification is offered as of August 1, 2005.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
