## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Manager storage and transport are:

- Controls all kinds of things about the transport and the depot of goods;
- Takes care to the flow of goods passing off smoothly;
- Monitors that the stock will be kept as small as possible.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager storage and transport can work in the middle management of a company in the dock industry, a transport company, a distribution firm or in a department transport and logistics of a production company.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**Average duration of the education/ training leading to the certificate**

**4 years (6400 study hours) (depending on previous education)**

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
