The most important duties of an Entrepreneur retail trade are:

Core task 1: Formulates a business plan and monitors business policy

- 1.1 Determines the objectives and strategy of the business
- 1.2 Makes a budget for investments and a financial plan
- 1.3 Makes a marketing plan
- 1.4 Analyses the sales figures and takes action
- 1.5 Monitors and interprets the financial situation
- 1.6 Builds up and maintains external business relationships
- 1.7 Determines the need for staff and takes on staff
- 1.8 Conducts discussions with colleagues

Core task 2: Manages and takes care of flow of goods and stock

- 2.1 Manages colleagues on receipt and in processing of goods
- 2.2 Supervises colleagues on receipt and in processing of goods
- 2.3 Manages and is responsible for the receipt of goods
- 2.4 Manages and is responsible for the storage of goods
- 2.5 Builds up and takes care of article presentations
- 2.6 Monitors the stock and orders
- 2.7 Makes purchasing plans
- 2.8 Takes care of the shop

Core task 3: Supervises sales activities and also carries them out

- 3.1 Manages colleagues in their sales activities
- 3.2 Supervises colleagues in their sales activities
- 3.3 Receives and addresses clients
- 3.4 Carries out sales and advisory consultations
- 3.5 Supplies made-to-measure work specific to the sector
- 3.6 Negotiates with the client
- 3.7 Places an order on behalf of a client
- 3.8 Deals with complaints

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
