3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round hairdresser are:

Core task 1: Prepares and finishes treatment

- 1.1 Makes appointments, receives clients and completes treatment
- 1.2 Cares for the hair and the scalp
- 1.3 Provides advice and promotes the sale of products/services

Core task 2: Carries out basic hair treatment

- 2.1 Cuts and styles hair
- 2.2 Blow-dries and styles
- 2.3 Cuts long hair
- 2.4 Styles temporarily
- 2.5 Wraps hair
- 2.6 Applies colouring products

Core task 3: Carries out specialised hair treatment

- 3.1 Does razor cut and styles hair
- 3.2 Applies permanent wave to hair
- 3.3 Colours and bleaches hair

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round hairdresser can work at various types of hairdressing enterprises: specialised salons for men or women, mixed and specific hair salons. Specific hair salons include fashion-sensitive and trendy salons, aimed at treating afro haircuts for example, or another certain market segment. Most hairdressing enterprises are mixed companies. There are also ambulant hairdressers. These are hairdressers who visit a client at home or in a care home or hospital.

<p>Access to next level of education/professions It is possible for an All-round hairdresser to develop to the VET-level 4 qualification Salon manager or become an independent entrepreneur, teacher or trainer. Further education in entrepreneurship is highly urged in order to become an independent entrepreneur.</p>	<p>International agreements The profession of All-round hairdresser is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25399 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
