3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled worker fresh produce trade, logistics and transport are:

Core task 1: Is responsible for the delivered goods

- 1.1 Receives, inspects and registers products
- 1.2 Divides up products
- 1.3 Is responsible for the logistics
- 1.4 Moves products around internally and stores them away
- 1.5 Is responsible for the good storage of products

Core task 2: Is responsible for the goods that are to be delivered

- 2.1 Makes products ready for sending
- 2.2 Moves products to external means of transport and delivers them

Core task 3: Organises and is in charge of working duties

- 3.1 Plans and divides up working duties
- 3.2 Supervises colleagues in professionally technical areas

Core task 4: Is responsible for quality policy

- 4.1 Contributes to the actualisation of care system
- 4.2 Informs colleagues about modernisations within care systems

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker fresh produce trade, logistics and transport works for a wholesaler that trades and processes food and green products. This includes trading and processing flowers, plants, potatoes, vegetables, fruit, or other living products and/or foods.

<p>Access to next level of education/professions With the certificate of Skilled worker fresh produce trade, logistics and transport, transfer is possible to a middle management or specialist course (qualification level 4). Within the sector, the Skilled worker fresh produce trade, logistics and transport can be promoted to managerial positions such as assistant business manager, team leader, box or shed head. The qualification/training to Manager fresh produce trade, logistics and transport is a good choice for this.</p>	<p>International agreements The profession of Skilled worker fresh produce trade, logistics and transport is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
