## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Manager port logistics are:

Core task 1: Acquires transport assignments for goods in the port

- 1.1 Makes contacts and maintains their network
- 1.2 Makes an inventory, provides information and advises the client
- 1.3 Negotiates with the client
- 1.4 Analyses and reports about developments in the market

Core task 2: Carries out administrative duties in connection with the cargo file

- 2.1 Processes administrative data in connection with the cargo file
- 2.2 Makes up documents in connection with the cargo file
- 2.3 Inspects and assesses the information in connection with the cargo file

Core task 3: Carries out organisational working duties in connection with the transport of cargo

- 3.1 Organises the transport of goods and combines consignments
- 3.2 Organises the arrival of different means of transport into the docks
- 3.3 Organises the accommodation and makes preparations in the docks for the departure of different means of transport
- 3.4 Organises the technical customs conclusion
- 3.5 Identifies and deals with problems
- 3.6 Monitors and inspects processes and procedures on the workforce

Core task 4: Manages and carries out staff policy

- 4.1 Manages colleagues
- 4.2 Monitors the teamwork
- 4.3 Organises work meetings
- 4.4 Provides a contribution to the departmental plan
- 4.5 Carries out performance and assessment interviews
- 4.6 Carries out the staff policy

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Working in the sector port logistics means working in an international and dynamic environment. The Manager port logistics has an important position in logistics and liaises with many different parties, such as ship brokers, shippers, transporters, and clients.

<b>Name and status of the body awarding the certificate</b> The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.	<b>Name and status of the national/regional authority providing accreditation/recognition of the certificate</b> Ministry of Education, Culture and Science
<b>Level of the certificate (national or international)</b> Qualification level 4 of the Dutch VET qualification structure Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures. <b>Access to next level of education/professions</b> After proven competencies, the Manager port logistics can be promoted to department manager or branch manager. He can also have a managerial position at the logistics department of a shipper or transport company. Within the higher vocational education, he can do the programmes for Logistics & technical transport and Logistics & economics.	<b>International agreements</b> The profession of Manager port logistics is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93040 The education and training for this qualification is offered as of August 1, 2009.	

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
