3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Fitter-machine assembler are:

Working under industrial conditions, the Fitter-machine assembler is required to carry out complex interrelated occupational tasks by reference to working drawings, orders, handbooks, regulations and instructions, and thus make products from metal, bars, sheet, piping and shaped sections, for use in construction and in the manufacture of (new) constructions and machinery. The Fitter-assembler is responsible for the implementation of his own package of tasks. In addition, the Assembler has hierarchical responsibility, namely monitoring and supervising the implementation by others of automated routines and standard procedures.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Fitter-machine assembler is employed in the construction and appliance building sector.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.

International agreements

The profession of Fitter-machine assembler is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
