## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The qualification has four contexts:

Economy and trade

Food and living environment

Technology

Care and welfare

The Labour market-qualified assistant (AKA) in the sector Economy and trade

The AKA in the trade sector is for example employed in a warehouse or shop. The AKA in administration is for example employed in an office (at reception or administration) of a company or institution. The AKA in the hotel, restaurant and catering sector, bakery, recreational and facility services sector is for example employed in a warehouse, production area, in cleaning or in a shop. The AKA in the cleaning and window cleaning sector is employed at cleaning companies responsible for cleaning interiors in various environments, for example offices and schools.

The AKA in the sector Food and living environment

The AKA in animal care is employed in a range of environments where animals are accommodated, such as petting farms, shelters, animal hotels, kennels, animal parks, livestock farms, stables and horse transport companies and specialist pet stores. The AKA in the green retail trade may be employed in street trading, the florist retail trade, flower wholesale or a garden centre. The AKA in nature and the living environment may be employed within a garden service provider or in the green maintenance service, in forestry and nature management, landscaping, the water and environmental technology or within a (technical green-based) recreational company. The AKA in plant production is employed in the primary sector in a labour-intensive plant-growing farm. The AKA in the food industry is employed in large, medium-sized or small businesses in the food industry or meat sector.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

#### The AKA in the sector Technology

The AKA in technology is employed at a company involved in one of the sectors and/or technology areas construction & infrastructure, graphic industry, mobility sector, mechanical & electrical engineering, process industry, painting and maintenance and plastering and finishing, wood & furniture, technical craftsman, bodywork, transport & logistics. The AKA is employed in a workshop, a production hall or at the customer location inside and out (construction site).

#### The AKA in the sector Care and welfare

The AKA is employed at the interface between residential living, care and welfare in care or welfare institutions or in the home of care recipients. He undertakes his tasks in particular in relation to the care recipient(s). He may come into contact with various categories of care recipients/clients, such as children, elderly care recipients/clients with limited self-care capabilities and mentally or physically disabled.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
