## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled worker animal business are:

The Skilled worker animal business can be employed in various subsectors of animal care. Within all subsectors, daily care of the animals is the central activity. Alongside animal care, interaction with customers plays an important role. The implementation of the activities is often subject to statutory professional requirements. The core of professional practice, animal care, relates to activities of reproductive and standardised types. In carrying out that practice, the Skilled worker must however be alert and able to respond to deviations in conditions or behavioural deviations of the entrusted animals. In most cases, the professional activities are carried out independently (not under supervision). In implementing the tasks, there is also a certain degree of preparation, for example making animal feed ready.

The Skilled worker animal business is responsible for undertaking his own activities.

- Skilled worker animal shelter, boarding kennel and kennel, animal park, specialist pet store
- Assistant manager animal shelter, boarding kennel and kennel (small businesses)

<b>Access to next level of education/professions</b> With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.	<b>International agreements</b> The profession of Skilled worker animal business is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 10586	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
