## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Installation planner works in the planning and control department of a company that installs technical products on the customers' premises. The company is active in one or a selection of the following work areas: electronics/automation; electro technical installations; climate control technology; mechanical installations; information and communication; measurement and control technique; refrigeration technique; insulation technique; metal/bitumen/synthetic roofing systems; distribution technology (gas/electricity and/or heat); machine construction.

The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

## Access to next level of education/professions

The Installation planner can develop into designer/project leader (Associate degree: Mechanical engineering, Electrotechnics, Installation technique, Industrial product design or Technical economics). He/she can also transfer to hbo to which the level 4 certificate gives access. Depending on the work context, he/she can choose technical/physics hbo programmes such as Mechanical engineering, Electrotechnics, Technical economics and Industrial product design.

### International agreements

The profession of Installation planner is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## Legal basis

Act on Vocational Education and Training (WEB), registered number of gualification (crebo): 92513 The education and training for this qualification is offered as of August 1, 2008.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
