The most important duties of an Environment officer are:

Core task 1: Carries out investigations in the environment and open spaces

- 1.1 Prepares for investigations into the environment and open spaces
- 1.2 Carries out investigations and measurements
- 1.3 Supervises during the performance of the working duties
- 1.4 Maintains the workplace and apparatus
- 1.5 Interprets and reports the results of environmental investigations and/or redevelopment

Core task 2: Carries out legal and regulatory requirements concerning the environment and open spaces

- 2.1 Makes reports and requests licences
- 2.2 Makes reports and/or gathers information about licences
- 2.3 Looks into and deals with complaints

Core task 3: Supervises and provides information about environmental aspects

- 3.1 Supports care systems
- 3.2 Interprets care systems

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Environment officer works for municipalities and provinces in the department of environment and/or spatial planning, for water boards, polder boards, consultancies, contractors that carry out investigation and remediation, and production companies.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97372 The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
