3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round machine operator for wood working are:

Core task 1: Processing wood through machine operation

- 1.1 Prepares machine working duties
- 1.2 Assembles production data
- 1.3 Selects, inspects and transports wood and sheet materials
- 1.4 Applies and adjusts cutting tools
- 1.5 Adjusts wood processing machines
- 1.6 Carries out test process
- 1.7 Carries out processes using wood processing machines
- 1.8 Completes assignment

Core task 2: Supervises process of production

- 2.1 Supervises and instructs wood processing machine operators
- 2.2 Monitors production process

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round machine operator for wood working can work at companies processing various types of wood and sheet material through machine operation. He can work in the furniture industry, (ship) interior construction, carpentering, timber trade or wood article industry.

The All-round machine operator for wood working can work on wooden/sheet product parts or finalised products which can be made with wood processing machines. It is possible these products are made on request.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
