- 1.1 Prepares the repair assignment for a passenger car
- 1.2 Carries out repairs on a passenger car
- 1.3 Inspects the repair work and completes the assignment
- 1.4 Supports and instructs trainees and colleagues in the repair work
- 1.5 Gives technical information to the client about the repair work carried out
- 1.6 Is responsible for sharing knowledge about repair situations within the business

Core task 2: Determines diagnosis concerning passenger cars

- 2.1 Prepares the diagnosis assignment
- 2.2 Makes a diagnosis of a passenger car
- 2.3 Checks the diagnosis work and completes the assignment
- 2.4 Supports and instructs trainees and colleagues in the diagnosis work
- 2.5 Is responsible for sharing knowledge about diagnosis situations within the business

The Technical specialist passenger cars works in workplace of passenger car companies such as dealers, universal or quick stop companies from the mobility branche.

Access to next level of education/professions The Technical specialist passenger cars can attend higher vocational education, choosing between Car technology, Mechanical engineering, Electrical engineering, and Business management.	International agreements The profession of Technical specialist passenger cars is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.														
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93430 The education and training for this qualification is offered as of August 1, 2009.															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	4 year(s) (6400 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
