## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Assistant logistics worker are:

Core task 1: Works as an assistant in a labour organisation

1.1 Prepares (assistant) work

1.2 Carries out (assistant) tasks

1.3 Reports on completing his (assistant) tasks

Core task 2: Assists in processing the goods flow

2.1 Receives goods and/or products

2.2 Prepares goods and/or products for storage and stores them

2.3 Collects (returned) goods, products, packaging and other packaging materials to be dispatched

2.4 Prepares goods and/or products for dispatch

2.5 Carries out actions on goods and/or products

2.6 Draws up an inventory of (part of) stock and/or warehouse stock

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Assistant logistics worker assists in the processing of goods flows in a company, for example a transport company or distribution centre.

After completion of the course, the professional is able to carry out simple tasks, under supervision. The Assistant logistics worker wishing to progress in the same field can advance to the level of basic professional practitioner as general or specialist logistic worker in a particular sector (for example the timber trade). 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).		

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
