#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Entrepreneur/manager animals for recreational purposes works within the service sector in animal care, and is for example employed at a riding stable, children's farm or animal sanctuary, kennel, animal hotel or animal park where recreational animals are kept. These businesses and/or institutions often not only have a recreational function but also an educational, sociocultural and/or therapeutic function.

#### OFFICIAL BASIS OF THE CERTIFICATE

#### Name and status of the body awarding the certificate Name and status of the national/regional authority The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education, Culture and Science pupil attended the programme.

#### Level of the certificate (national or international) Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

#### Access to next level of education/professions

Reaching the position of manager, the Entrepreneur/ manager animals for recreational purposes can transfer to full entrepreneurship. As a business owner he can broaden his business, or start as an entrepreneur in another associated sector. At higher professional education level, there is a study programme in animal management. Following completion of this programme depending on the specialisation selected – the graduate can be employed in the animal feed or veterinary medicine industry, at trial animal and research institutes, zoos, animal sanctuaries, animal health services, nature and animal conservation organisations or in government.

## International agreements

The profession of Entrepreneur/manager animals for recreational purposes is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97730 The education and training for this qualification is offered as of August 1, 2011.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE Average duration of the education/ training leading to the certificate 4 years (6400 study hours) (depending on previous education)

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
