#### PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Nurse (hospital care) are:

Core task 1: Offers support with personal basic care

Core task 2: Offers support in the psycho-somatic and social area

Core task 3: Performs nursing activities

Core task 4: Applies prevention and gives information, advice and instruction

Core task 5: Coordinates and organises the care

Core task 6: Contributes to the organisation and management of the work unit

Core task 7: Contributes to the advancement of the care

The Nurse (hospital care) is focused on care for the individual care recipient and his direct environment, whereby the relationship with the care recipient is crucial for her work. Individual health care means to asses, advance, assure, protect or recover someone's health. The Nurse also performs duties that advance the health of the society. These are mostly pre-emptive duties. This prevention is focused on both the individual care recipient as groups of care recipients.

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Nurse (general care) can work in the hospital, the nursing and convalescence homes and homecare, care for the disabled and mental health care. The job title may differ per branch or care setting.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
