Core task 3: Performs service activities

- 3.1 Informs and refers people
- 3.2 Performs (auxiliary) administrative work
- 3.3 Provides information
- 3.4 Creates and uses network

The Enforcer surveillance and security supervises or assists in a correct use of the public area and is the first professional link in the chain of public safety.

<p><b>Access to next level of education/professions</b> With the certificate of Enforcer surveillance and security, transfer is possible to a middle management or specialist course (qualification level 4).</p> <p>An Enforcer surveillance and security can rise to become a team leader, group leader, environmental supervisor, worker for the Dutch general information and security service (AIVD). These career opportunities can become available after advanced training.</p>	<p><b>International agreements</b> The profession of Enforcer surveillance and security is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>														
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94810 The education and training for this qualification is offered as of August 1, 2008.</p>															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
