3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Road worker are:

Core task 1: Carries out road works

- 1.1 Sets up and maintains temporary traffic signs
- 1.2 Sets up and maintains work terrain
- 1.3 Makes cables and wiring safe
- 1.4 Digs up, fills up, raises and closes off the ground
- 1.5 Inspects foundations and lays surfaces
- 1.6 Sets channels and drains, places road drains and fittings, lays road drainage
- 1.7 Lays road surfaces
- 1.8 Completes road surfacing work
- 1.9 Removes and/or places road furnishings
- 1.10 Repairs/ renews hard surfaces, road drains, drainage channels and fittings
- 1.11 Lays temporary hard surfaces
- 1.12 Sets up work area at the agreed road

Core task 2: Organises the daily working duties of the team.

- 2.1 Divides up the working duties and instructs colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Monitors the progress
- 2.4 Discusses and comes to agreement with third parties
- 2.5 Reports to the manager

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Road worker works in the road and waterway sector and is active in small, medium-sized, or large companies. The main activities of such companies consist of laying new surfacing, resurfacing, repair, service, and maintenance.

<p>Access to next level of education/professions The Road worker can rise to become operator, supervisor, planner or planning officer. In addition, the road worker can enter a qualification at level 4, for instance, the qualification of Supervisor construction, infrastructure and specialised contracting.</p>	<p>International agreements The profession of Road worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94010 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
