3. PROFILE OF SKILLS AND COMPETENCES

The most important tasks of the Supervisor forestry and nature management are:

- managing the group of employees;
- planning the daily activities in forestry and nature management;
- preparing the work;
- supervision of implementation of the entire work process;
- evaluation of the result;
- tasks in respect of offers/calculations, design/schedule of requirements, timber trade and acquisition;
- operational tasks (depending on the business).

The Supervisor forestry and nature management plans the activities to be undertaken, provides management and issues assignments, supervises the work, carries out inspections, registers hours and material used. In addition, middle management employees forestry and nature management influence the company/department policy, HRM issues and financing.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor forestry and nature management can for example be employed by a government organisation such as municipalities or provincial authorities, a foundation or water board, a sports association, for example for golf courses, a recreation company, a consultancy firm or a business including a landscape gardener or green contractor. The Supervisor may work within an organisation that owns or manages a nature and landscape area. The profession is also known by the following names: General supervisor; personnel supervisor; site supervisor; implementation officer, forest officer, manager.

International agreements The profession of Supervisor forestry and nature management is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	4 year(s) (6400 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
