3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Ship metal worker are:

Core task 1: Constructs products

- 1.1 Does preparatory work for one's own work
- 1.2 Sets and adjusts machine and tools
- 1.3 Manufactures and transforms material
- 1.4 Measures and checks manufactured products
- 1.5 Rounds off completed work

Core task 2: Repairs and modifies ships

- 2.1 Does preparatory work for ship repair and modifications
- 2.2 Repairs and modifies ship parts
- 2.3 Completes ship repair and modification work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Ship metal worker works in the metal products industry, on seagoing ships, naval ships and inland shipping vessels. He mainly carries out repairs and modifications.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
